## 1. AGE AND DATE OF BIRTH

**Please Note:** Dates of birth for classes restricted by age: (relative to ActewAGL Royal Canberra Show dates):-  
**over 8 months and not over 12 months:** born in March, April, May and June 2016  
**over 12 months and not over 14 months:** born in January and February 2016  
**over 14 months and not over 16 months:** born in November and December 2015  
**over 16 months and not over 18 months:** born in September and October 2015  
**over 18 months and not over 20 months:** born in July and August 2015  
**over 20 months and not over 24 months:** born in March, April, May and June 2015  
**over 24 months and not over 30 months:** born in September, October, November, December 2013 and January and February 2015  
**over 30 months:** born on or before 31 August 2014

## 2. AGE OF EXHIBITORS

Persons under the age of 14 years will not be permitted to lead animals (other than in junior events) except at the discretion of the Chief Ring Steward.

## 3. ANIMALS THAT ARE NOT ENTIRE

A male animal shall not be eligible for exhibition, except in Steer Classes, if it is not entire. All genitalia shall be complete, properly formed and proportioned for normal reproduction.

## 4. APPLICATION FOR ENTRY

An exhibit may only compete in the class in which it is entered.  
**Information as requested on the application for entry must be completed otherwise the application will not be accepted. All entries are exhibited at the exhibitors own risk.**

## 5. SUBSTITUTIONS

A substitution is only permitted in a 'like for like' scenario i.e. original entry is in a bull class 8mths and over, the substituted animal must also be in the bull 8mths and over class. Heifers can't be substituted for a bull and likewise. They must be of the same sex and replace the withdrawn animal in the same class. All substitutions must be notified in writing to the Show office prior to the 15 January 2017.

## 6. BEDDING

One bale of bedding straw will be provided for each exhibit. Fodder and additional bedding will be available for purchase on the ground.

## 7. BREAST PLATES

The Cattle Section has recyclable numbered plates. These plates have a life expectancy of several years and will reduce wastage. A \$10 bond will be required at the time of entry for each exhibit. This bond is included in the entry price of \$110. These plates must be returned to the Cattle

Office during the specified times as displayed, at which time your bond will be refunded. Please assist us by returning them on time. It won't be cost effective to take them home and send them back in the mail. Help us be good citizens by supporting our recycling policies. **Any plates which have been written on with permanent marker or damaged will not be refunded the \$10 bond. Stickers are available on the back of the breast plate should you need to write anything. Please do not deface the breastplate.**

## 8. BREED CAPTAINS

Each Cattle Breed Society with entries must nominate a person qualified to act as Breed Captain. The Society must approve the nominee/s and may request additional nominees.

Each Breed Captain, as directed by the Chief Steward, shall be responsible for the conduct and parading of the exhibits of that breed.

**Breed Captains will be responsible for ensuring that all Champions and Reserve Champions of the breed are ready to attend each Grand Parade. Dust-coats or breed approved attire MUST be worn in the Grand Parades. Suitable footwear, ie hard covered boots must be worn, not permitted are gym shoes, runners, thongs, open sandals or high heels.**

**ALL BREED CAPTAINS MUST ATTEND THE CHIEF STEWARD'S MEETING AT 9am ON THURSDAY 23 FEBRUARY AT THE CATTLE OFFICE.**

## 9. BREEDERS GROUP

### ENTRY REQUIREMENTS

Exhibits in the breeders group must be owned and bred by the Exhibitor and drawn from competitive classes and consist of two bulls & one female, or vice versa.

## 10. CALVES AT FOOT

Calves at foot must be eligible for registration and tattooed OR display permanent breed society identification. They must be no more than 8 months old at the time of the Royal Canberra Show.

## 11. CANCELLATION OF THE SHOW

It is agreed between the parties that if at the discretion of the Directors or Chief Executive Officer or some other authorised officer, that the Show is to be partially or fully cancelled for any reason whatsoever, the Exhibitor shall not pursue the Society for the recoveries of lost income or damages. This complete bar to an action applies to all headings of Law, whether it be Common Law in Contract or Tort or pursuant to any State, Territorial, or Commonwealth Statute Law. It is acknowledged by the Exhibitor that the Society has no duty to have a Show in any particular year and that this Clause operates as a complete defence for the Society to any such action.

## 12. CLEANING OF STALLS, FEEDING

Each Exhibitor shall be responsible for the removal of all manure from the stall in which their exhibit is stalled. In case of a breach of the provision, the Society may effect

the removal and the Exhibitor shall contribute to the Society \$40 per stall per day towards the cost of such removal.

An exhibit not fed and/or watered either by the Exhibitor or their agent, will be fed and/or watered by the Society and a fine of \$100 plus costs will be charged to the Exhibitor or their representative.

### 13.CONDITIONS OF THE NATIONAL CAPITAL STEER & HEIFER HOOF & HOOK COMPETITIONS

The Sale will be run under the terms and conditions of the Stud Stock Salesman's Association.

All cattle entered in the Sale must have been entered in the National Capital Steer & Heifer Hoof & Hook Competitions conducted at the 2016 ActewAGL Royal Canberra Show.

### 14.DOG MANAGEMENT POLICY

NO DOGS ALLOWED. If you bring a dog, you will be asked to leave. Your entries will be cancelled and there will be NO refund given.

### 15.ENTER AT OWN RISK

The exhibitor enters entirely at his own risk. In case any exhibit whilst on the Society Showgrounds shall cause or be the cause of injury or damage to any other exhibit or exhibitor or to the personal property of any member of the Society or the general public, the owner of such exhibit shall indemnify and keep indemnified the Society, it's officers, officials and members from and against all damages, costs, claims, expenses or liabilities incurred in connection with such exhibits. The exhibitor shall be liable to the Society and it's employees, officers and officials for any damage or loss occasioned to any of them by the exhibit or the exhibitor or his agent.

### 16.TATTOO CHECKING

From the 2017 Royal Canberra Show onward, we will commence checking all tattoos for bulls and heifers using the crush provided within the showgrounds. The reason for this is to ensure that OH&S requirements are met for both the individuals and the animals' safety. Tattoo checking will be carried out in breed order and a scheduled timetable will be posted on the cattle office and your breed captains will be advised of proposed times.

### 17.EXHIBITOR PASSES

Passes will be issued as follows:

1-3 head - 2 passes

4-5 head - 3 passes

6 or more head - 4 passes

Any additional passes may be purchased at a cost of \$10.00 per one-day pass.

### 18.FIREWORKS

A fireworks display will be held on Friday & Saturday night at 9.15pm. Please ensure your animals are correctly attended during this period

### 19.GRAND PARADE

Grand Parade Times: Saturday 4.00pm  
Sunday 2.30pm

It is the condition of entry into the ActewAGL Royal Canberra Show that every broad ribbon winner is required to take part in the Grand Parade on the Arena at the times set out above. Failure to parade will entail a penalty of \$100 (per exhibit), forfeiture of prize money, awards, and/or non-acceptance at any subsequent ActewAGL Royal Canberra Shows.

### 20.GRANDSTANDS AND SEATING ACCOMMODATION

Persons occupying grandstands or other seating accommodation on the Showground do so at their own risk, and no claim shall be made against the Society in respect of any loss or injury by reason of any defect or accident, or by reason of any act or omission whether negligent or otherwise, on the part of the Council or an employee or agent of the Society, or on the part of any other person.

### 21.GROOMING FRAMES

Exhibitors who have applied for allocation of space and paid the \$30 fee will be permitted to bring a grooming frame onto the Showground. The frame may only be placed in the space allocated by the Society. Any grooming frame brought onto the Showground without prior permission will be immediately impounded by the Society and will only be released to the Exhibitor outside the Showground and upon payment of a fee of \$200. **The use of powered washers is prohibited.**

**22.HEALTH REGULATIONS** Any animal infected by ringworm or warts will be deemed to be ineligible for exhibition at the Show. The Inspectors shall report any animal that they believe to be infected by ringworm or warts to the Society's Veterinarian who will inspect such animal for the purpose of determining whether the animal is so infected.

Without prejudice to the General Regulations, the determinations of the Inspectors or of the Veterinary Surgeons on any matter shall be subject only to appeal to the Chief Steward in the Cattle Section who shall make such determinations and directions as he thinks fit. Such determinations and directions shall be final and may not be called into question in any manner or in any proceedings whatsoever.

Cattle from any State or Territory of the Commonwealth of Australia are eligible for entry provided they are not subject to quarantine or restriction with respect to Tuberculosis, Johne's Disease or any other notifiable disease. Upon receipt of each entry the Society may request the Government Veterinary Officer of the State or Territory of origin of the exhibit to certify from existing records that the exhibit is not subject to quarantine or restriction with respect to Tuberculosis, Johne's disease or any other notable disease. The certificate of the Government Veterinary Office shall be conclusive evidence of the facts contained therein.

### 22.A JOHNE'S DISEASE

Except where the Society at its absolute discretion may determine otherwise, no cattle may be exhibited unless from a herd, stud or property for which a Johne's Disease Health Declaration has been submitted to the Cattle Section by the closing date of entries. The Exhibitor must sign a Johne's disease Health Declaration in such form as the Society may require.

## 22.B PESTI VIRUS

**ONLY tested and cleared animals will be accepted on the grounds. Non-tested animals WILL NOT BE PERMITTED ON THE GROUNDS. Note that all exhibits including calves must have clearance!**

Please ensure that your animals are tested in consultation with your vet and testing certificates are provided prior to the Show. If your animal is not tested and documentation cannot be provided, the entry will not be accepted.

**HOOF & HOOK STEERS & HEIFERS MUST BE IDENTIFIED ON THE TEST RESULTS BY THEIR NLIS NUMBER.**

## 23.INSPECTIONS

Each Cattle Society in the Beef, Steer or School Sections will appoint a Breed Captain or other person approved by the RNCAS to assist with inspections.

Each animal will be subject to identification and inspection by the Inspector appointed by the RNCAS.

Inspections of all cattle will commence at times to be determined by the Cattle Committee.

Exhibitors are required to have their stock attended and clean in readiness for inspection at the time specified on the relevant day.

The Inspectors, Veterinary Surgeons, Chief Steward, or their assistants will not be required to furnish to the Exhibitor any reasons for their determinations or directions, or to give the Exhibitor any right to be heard on any matter in question.

Without Prejudice to any other applicable rules, the Cattle Committee may determine that an exhibit will not be accepted for exhibition due to any of the following reasons:

- The exhibit is not considered of sufficient merit to be exhibited.
- The exhibit has not been adequately prepared.
- The exhibit bears any marking brand or tattoos inconsistent with the marking, brand or tattoos disclosed on the relevant entry form or Breed Society records or whose tattoo is not clearly legible.
- A bull 8 mths or over has not been ringed.
- Any exhibit under 18 mths must not show evidence of a permanent tooth.
- Any exhibit entered in an under 24 mths class must not show evidence of more than two permanent teeth.
- Any calf at foot, born prior to entry to the Showground must be tattooed.
- Calves at foot must be no older than 8 months on judging day.
- All females must be exhibited with a nose clip or ring.

Any dispute regarding the age of an exhibit shall be adjudicated by the Society's Veterinarian and on inspection of the exhibit in question, his decision shall be final and not

be called into question in any proceedings or in any manner whatsoever.

If the relevant Inspector determines, or the relevant Inspectors unanimously determine, that any animal entered for exhibition:

- has not been adequately prepared for the Show; or
  - bears any markings brand or tattoo inconsistent with the markings brand or tattoo disclosed in the relevant entry form or Breed Society records or whose tattoo is not clearly legible;
- Or
- has a calf at foot born prior to arrival at the Showground, that is not tattooed with its permanent ink impregnated tattoo then such animal shall be deemed ineligible for exhibition at the Show.

All exhibits must comply with the Property Identification Code and National Livestock Identification Scheme legislation of NSW. Exhibits not appropriately identified by means of an electronic identification will be deemed ineligible. NLIS tags will be read on 24 & 25 February 2016. Property Identification Code must be provided at the time of entry.

## 24.INTRACTABLE ANIMALS

If at its absolute discretion, the Society determines any exhibit or exhibits of stock to be dangerous for any reason whatsoever, the Society may by notice to the Exhibitor, require the exhibit concerned to be removed from the Showground. The Exhibitor upon receipt of such notice shall remove such animal immediately.

## 25.JUDGING

The Society may change the Judge for any particular class, at any time, if it deems fit. Judging will be conducted by a Single Judge System except for judging of the Inter Breed.

No exhibit shall receive an award, if in the opinion of the Judge it is unworthy of such award.

Exhibits shall be present at the appropriate judging ring and ready to enter the judging ring at the time specified for the event to take place. Exhibits shall enter the judging ring immediately upon request by the appropriate Steward. Persons in charge of exhibits must under no circumstances leave their exhibits unattended, at or in the judging ring.

No Competitor or Exhibitor or person acting on behalf of any Competitor or Exhibitor shall in any way influence, consult or interfere with or attempt to influence, consult or interfere with the Judge or endeavour to interfere with his freedom of choice or judgement.

No exhibit or person in charge thereof shall be equipped with, wear or display anything that indicates the ownership of the exhibit before or during judging, unless this practice is expressly authorised in the Regulations in the relevant schedule.

The decision of the Judge as to the merits of the exhibit and the Competitor, shall be final and binding, whether or not such decision was made or purported to be made in accordance with these or any other relevant regulations, and no appeal may be made or order for review or similar

order sought there from to any court of law or other body on the question of merit of the exhibit, or on any matter arising out of or in connection with the manner in which the Judge's decision was made, or purported to be made or otherwise.

Subject to the Regulations in the relevant schedule, the Judge may award a second or third prize instead of a first prize, or may withhold a prize altogether where he considers in his absolute discretion, that such prize not be awarded.

Subject to the Regulations in the schedule, should there be a tie for any placing in any event or class, subsequent placing's in that event or class will be awarded such that the next placing will be the sum of the number of exhibits already placed plus one. (For example, if two exhibits tie for first place, the next placing to be awarded is third).

## 26.ENTRIES

c: No late entries accepted after 4 January 2017.

**d. NO ENTRIES WILL BE ACCEPTED OR PROCESSED WITHOUT ALL ACCOMPANYING PAPERWORK I.E. NATIONAL CATTLE HEALTH DECLARATION, PI TESTING RESULTS, NATIONAL VENDOR DECLARATION (HOOF & HOOK) & REGISTRATION CERTIFICATES. THE ONLY EXCEPTION WILL BE TEST RESULTS ON CALVES AT FOOT NOT YET BORN AT CLOSE OF ENTRY.**

27.Smoking is not permitted in any cattle pavilions or marquees or in any enclosed public places, outdoor eating and drinking places ([Smoke-Free Public Places Act 2003](#))

## 28.PARADES AND ATTIRE

Unless otherwise directed, an attendant of an exhibit (or breed sign carrier) whilst parading such exhibit either before a Judge or in the Grand Parade, shall wear a clean, approved dust-coat or other breed approved attire. Such dust-coat or breed approved attire must in no way show any insignia or any descriptive markings indicating the exhibitor's name and/or stud name or prefix. Suitable footwear, i.e. hard covered boots must be worn. Not permitted are gym shoes, runners, thongs, open sandals or high heels.

## 29.PARKING

Private vehicles other than cattle transport will not be permitted onto the ground.

Cattle transports are to be parked in the area set aside for that purpose. Trucks Trailers etc.; will be required to park in the designated off-site location advised by the Cattle Committee upon arrival

## 30.PERSON IN CHARGE OF AN ANIMAL

The Owner or his/her representative is responsible for the animal's care and well-being for the duration of the Show.

## 31.PREPARATION OF EXHIBITS

Preparation other than normal feeding and fitting, with the exception of dressing of hair, hoofs and horns, is not permitted. The use of GLUE is strictly prohibited. Any operation materially altering the structure of the natural conformation of any part of the animal's body (including head, legs and tail), whether by introduction of iron, liquids or other substance subcutaneously into any part of the body and any surgical or chemical operation correcting, deleting or minimising defects or changing by exaggeration or otherwise, the natural conformation of the animal and any operation intended to do so, is prohibited.

Should the Society be of the opinion that the coat of any exhibit has been tinted and/or coloured in any way, then such an animal shall be deemed to be ineligible for exhibition at the Show.

The use of powered washers is prohibited.

## 32.PRIZE MONEY

All prize money is GST inclusive. Prize money is to be collected from the Cattle Committee Office during the Show. Any prize money not collected before the closing of the Show will be forfeited.

## 33.PUREBRED

All beef cattle exhibits to be the progeny of registered sire and dam of the same breed and must have been fully accepted for registration by a recognised Cattle Breed Society. Proof of registration and ownership must accompany the application for entry. An entire copy (both sides if applicable) of the registration certificate must be provided at time of entry.

Exhibits in the beef breed classes must conform to the rules and regulations of the Breed Society with which they are registered, before being eligible for exhibition and/or to gain an award.

## 34.REJECTION OF ENTRIES AND/OR EXHIBITORS AND/OR COMPETITORS

Exhibitors must, if required by the Society, make a statutory declaration in such form, and with respect to such matters regarding their entries and otherwise, as the Society may in its absolute discretion require.

**NO Hoof and Hook entries or payments for these entries will be accepted without a completed Vendors Declaration. A copy of the NVD must be forwarded at time of entry.**

Effective 16 November 2015 the LPA Advisory Committee is withdrawing recognition of all versions of the LPD NVDs except the most current version, which is April 2013 (0413) version for cattle.



### 35. CODE OF CONDUCT & ACCEPTABLE

**BEHAVIOUR** The Society reserves the absolute discretion to refuse to accept any exhibit, Exhibitor or Competitor for entry in any event, or at the Show, and to withdraw, disqualify, suspend for any period (and particularly future Shows conducted by the Society) or otherwise penalise any exhibit, Exhibitor or Competitor prior to or in the course of any event, or upon the conclusion of any event (whether before or after the event has been judged) and generally to adjudicate on, and finally determine, any matter whatsoever concerning or in any way related to the Show, involving the performance or conduct of any exhibit, Exhibitor or Competitor. Well worded and all encompassing which is what is needed.

### 36. RESTRICTION OF ENTRIES

If total entries are in excess of the number of cattle capable of being stalled, the Society reserves the right to request intending Exhibitors to reduce the number of animals entered.

### 37. RIBBONS

In a single class, a ribbon or other evidence of a previous award, shall not be worn or displayed in the ring. Subject to the Regulations, prize ribbons may be awarded throughout the Cattle Section to 5<sup>th</sup> place. **Supreme Champion of the Breed Ribbon** will only be awarded where both sexes are represented.

### 38. SAFETY PRECAUTIONS

#### CATTLE STALLS / CATTLE MARQUEES

**Smoking is prohibited in the cattle stalls and cattle marquees.**

Exhibitors are advised that the use of primus stoves, or any heating or lighting appliances of a like character, or any naked light, within or in the vicinity of the cattle stalls or cattle marquees, is forbidden.

### 39. SECURITY OF ANIMALS

All bull exhibits of beef, dual purpose cattle over the age of 8 months, shall be ringed through the nose and at all times be led by such ring.

If the Stewards or the Society's officials determine that any bull is unsafe, such bull shall be placed under such control as directed by the Stewards or the Society's officials.

All females must be provided with effective halters and be thoroughly broken to lead. In the Beef Section all females must be fitted with a nose grip when being led.

All Led Steers must be fitted with either a ring or nose grip when being paraded.

**Every poll bull and every wholly or partially dehorned bull or steer entered in the Beef and Steer Sections, must be securely tethered by an effective headstall, in addition to a neck strap or neck rope.**

Each Exhibitor shall ensure that each of their exhibits is securely tethered in its stall.

Please note - modifications of, or additions to tie up facilities is strictly prohibited.

All Exhibitors of Beef Cattle must provide neck straps or neck ropes, as well as halters for tethering their cattle. When not stalled, they shall ensure that exhibits are not left unattended.

### 40. SIRE'S OR DAM'S PROGENY CLASS ENTRY REQUIREMENTS

Exhibits in the progeny group are to be drawn from the competitive classes and both sexes must be represented with the name of sire or dam stated on the application for entry, and do not necessarily have to be owned by one owner.

### 41. STALLS

An exhibit may not be stalled in any other stall than the one allocated by the Society to the Exhibitor. A calf must be stalled with its mother and though tethered, must have unrestricted access to her at all times.

Each exhibitor is permitted to display a "Sign" 1200mm x 600mm, to advertise their stud.

### 42. STOCK FLOATS

All stock must be unloaded from vehicles as soon as possible on arrival. Once unloaded, the vehicle must leave the Showground and park in an area set aside for that purpose.

Drivers of vehicles carrying stock to or from the Showground must conform to the instructions issued to Exhibitors or their agents.

### 43. TAMPERING OF EXHIBITS

No Exhibitor shall be permitted to exhibit any cattle, which in the opinion of the Society, displays evidence of being tampered with or, in the definition of the class in which it is entered, an animal entered for exhibition or competition is not presented in its natural conformation and has no preparation other than normal feeding and fitting with the exception of normal dressing of hair, hoofs and horns.

The following practices are strictly prohibited:

- a) An operation or any kind of surgery materially altering the structure or the natural conformation of any part of the animal's body.
- b) The infusion or injection of any drugs or any other substance or the insertion of any object into the teats, blood vessels, muscles or under the skin of any animal to restrict the flow of milk or alter its natural physical attributes.
- c) The setting of the teats of an animal with any form of glue or other setting substance or any other action which alters the natural teat placement of an animal.

Evidence of such practices renders an exhibit liable to instant disqualification and the Exhibitor or/his/her agent liable to a suspension range from 5 years to lifetime. It is the Exhibitor's responsibility to ensure the animal is not subject to prohibited practices, prior to and whilst on the Showground.

The Society may make or cause to be made, any test of any exhibit to determine whether any drug or other substance has been administered to the exhibit and may take possession of any such exhibit for any of the aforesaid purposes and detain such exhibit for such period as the Society deems necessary.

Procedures for the testing of prohibited substances may include random tests on exhibits.  
Should a positive test to a prohibited substance or practice result, any costs associated with testing will be borne by the Exhibitor.

#### 44. TIME OF ARRIVAL

Enter the Showground via the Well Station Road Entry – Gate 7 – this gate will be clearly signed.  
Beef Cattle will not be admitted before 12noon on Tuesday 23 February or after 8.30am on Thursday 25 February.  
Commercial Steers & Heifers cannot arrive any later than 12noon Wednesday 24 February.

#### 45. TIME OF DEPARTURE

All cattle are to remain on the Showground until **5.00pm Sunday** 26 February with the exception of Purebred Steers who may leave on completion of Judging.  
Exhibitors travelling the furthest distance will be entitled to leave first. Please ensure you complete the Distance field on your entry form. If this is not completed you will not receive a numbered truck departure ticket which will be included in your exhibitors pack.  
If any exhibitor is found to be leaving early the RNCAS Cattle Committee has the right to reject all entries from that Exhibitor at the proceeding Show.

#### 46. WEIGHING & MOUTHING

All bulls entered in the Beef Section of the Royal Canberra Show will be, prior to judging, weighed and mouthed.  
Weights will appear on the neck cards for the Judge's use.  
It will be the responsibility of the Exhibitor that his/her entry has been weighed and mouthed prior to judging. The exhibit will be disqualified if the weighing and mouthing have not been completed before the exhibit is due in the ring.

#### 47. WITHDRAWALS

- a) Exhibitors who subsequently are unable to exhibit and who advise the Society in writing no later than 30 January 2016 on the form provided will be refunded \$50 per entry.
- b) No refund will be offered for any withdrawal made after 30 January 2016 except for:
  - i) the death of the exhibit;

- ii) the exhibit is unfit by way of injury or ill health as certified by a veterinary surgeon (a certificate must be provided); or
  - iii) any other reason satisfactory to the Cattle Committee or its representative;
- c) An Owner will not be allowed to exhibit any of their entries if the fine imposed has not been paid within 24 hours after the time of commencement of the inspection of that breed.
  - d) Late Withdrawals – if a late withdrawal is made i.e. less than 24hrs prior to judging, the exhibitor will incur a fine of \$10.

#### 48. WORKPLACE HEALTH & SAFETY ACT

Any Exhibitors intending to bring electrical equipment to the Showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers, and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor.  
This is essential for the safety of you (the Exhibitor), fellow Exhibitors and the general public and is a requirement of the Occupational Health and Safety Act of 1989. The Act imposes very severe penalties in the event of non-compliance with its provisions. Any Exhibitor who does not comply will not be allowed to exhibit.

#### 49. PRIVACY ACT STATEMENT

The information provided by Exhibitors is used by the RNCAS to organise, process and conduct Competitions. By entering such Competitions, Exhibitors consent to their personal information being used for this purpose including this information being made available to RNCAS sponsors, breed societies, the media, the public, promotional purposes, archival purposes, published in RNCAS publications and could be made available to other third parties for the purpose of promoting the RNCAS, or as otherwise required by law. Exhibitors have a right of access to and alteration of personal information concerning themselves in terms of the Privacy Act. This may be done by contacting the coordinator of the Competition at the RNCAS (02) 6241 2478, or in writing to the RNCAS, P O Box 124, Exhibition Park, ACT 2911. The RNCAS may publish the results of any disciplinary proceedings against Exhibitors in accordance with the RNCAS General Regulations.

Camping sites for the 2017 ActewAGL Royal Canberra Show have significantly changed due to changes to the physical grounds of EPIC and the needs of the RNCAS. Traditional camping locations may no longer be in existence. New camping sites will be developed to cater for the larger transport rigs. Every endeavour will be made to locate camping sites near where your cattle are located. Please ensure you read the site rules and requirements before applying for camping. All applications for camping must be made at the same time as entering your cattle for the 2017 Show.

**Camping is only permitted for the period Tuesday 21 February 2017 from 12.00 noon to Sunday 26 February 2017. All campers must leave the grounds by Monday 27 February 2017.**

Camping sites will be allocated according to the size of vehicles & camping facilities as specified on this form. A standard camping site is 8m x 3m. If your vehicle(s) or camping facilities when fully set up exceed 8m X 3m you are required to book and pay for extra 8m x 3m sites, sufficient to accommodate your vehicle(s) and all other equipment as set up. Ensure annexes are included in your measurements.

Vehicles allowed on the camping site will only be the camping rig. Service vehicles will only be permitted at the discretion of the camping staff and adequate space to accommodate the vehicle within your defined site must be booked and paid for in advance. If service vehicles are not allowed the difference in the fee will be refunded. Every vehicle must be applied for on the camping form to receive authorised camping stickers. **Vehicles must be housed only on the site booked. Any vehicle not authorised will be removed from the camping zones and moved to the offsite parking areas.**

Special areas will be developed for storage of floats or trailers for people staying off site.

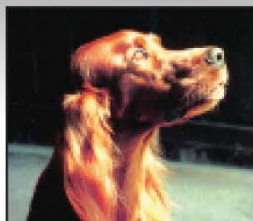

### *Carcass Judging will be conducted under ABCAM Version 4.2* **AUSTRALIAN BEEF CARCASS APPRAISAL METHOD (ABCAM 4.2)**

ABCAM Version 4.2 has been developed from extensive experience in carcass evaluation, and research by the Beef CRC, NSW Agriculture and Meat Standards Australia. It uses the best available carcass assessments, and aims to give feedback to producers about compliance of beef carcasses to market specifications, the yield of saleable meat, and the potential eating quality.

#### Market Specifications (15 points)

Most markets require carcasses to meet basic specifications of age (dentition), sex, weight and P8 (rump) fat depth. Dentition and sex are usually checked in the live cattle, and are not part of the carcass assessment. *Penalties* may be applied to carcasses that fall outside the specified weight range, which show Secondary Sexual Characteristics, fall outside specifications for dentition, or exhibit obvious defects, e.g. bruising, blood splash, injection site damage.

*P8 Fat Depth* is measured at the P8 site, over the rump, and is part of the AUS-MEAT national carcass description language. It is commonly used to set market targets and for payment of premiums and discounts. Optimum P8 fat depth is the range set for each class in the carcass specifications.

*Fat Colour & Texture* have no impact on eating quality, but excessive yellowing or softness will affect the saleability of the carcass. Carcasses are assessed using the AUS-MEAT chips (0-9). Optimum fat colour and texture are chips 0-1, a white firm fat.

#### Saleable Meat Yield (40 points)

Saleable meat yield is the weight of primal cuts and meat trimmings, obtained from the carcass that is available for sale as retail product. It excludes bone and waste fat. High-yielding carcasses are heavily muscled with a thin, even fat cover, but the fat depth and distribution must be adequate to meet quality requirements.

**Muscle Score** is a visual assessment of the thickness and fullness of the carcass muscle development, allowing for the effect of fatness. Muscle Score has been shown to have a strong relationship with carcass yield. This is a different assessment to AUS-MEAT Butt Profile, which includes fat and does not assess muscle volume. Muscle score is assessed using the same scale used in live animals, that is A+ for very thick and heavily muscled carcasses to E- for very narrow, poorly muscled carcasses. The greater the degree of muscling the higher the points awarded.

**Rib-eye Area** (or eye-muscle area) is measured in square centimetres at the quartering site (10/11<sup>th</sup> or 12/13<sup>th</sup> rib) and points awarded according to the area measured in relation to the carcass weight. The larger the rib eye area in relation to the carcass weight the higher the points awarded.

**Rib Fat Depth** is a good indicator of carcass yield with over fat animals having lower yields. It is measured in millimetres at the quartering site (10/11<sup>th</sup> or 12/13<sup>th</sup> rib). Optimum rib fat depth is the range set for each class in the specifications.

#### **Eating Quality (45 points)**

This section reports the key factors that the judge can assess, and which the producer can control. It is important to recognise that eating quality is significantly affected by other factors such as carcass hanging method and electrical stimulation, carcass chilling rate, and post slaughter aging, however these factors are out of the producer's control. *pH* is a measure of the acidity of meat after slaughter, resulting from the conversion of muscle glycogen (energy reserves) to lactic acid. High pH meat (over 5.7) can result from factors including pre-slaughter stress on the animal. High pH meat is generally associated with a dark meat colour, toughness and poor keeping quality. Maximum points are awarded to carcasses with pH of 5.59 or lower. *Meat colour* is important in purchase decisions by consumers with most markets preferring a bright, pinkish red colour. Carcasses are assessed for meat colour at the rib-eye using the AUS-MEAT chips (1A-7). Optimum meat colour is in the range 1A-1C.

**Weight for Maturity (Ossification):** Carcass maturity is indicated by the degree of ossification (development of cartilage to bone) at the sawn backbone (chine). Ossification is scored from 100 (about 9 months) to 900. Younger carcasses are more tender, and at the same maturity, heavier carcasses are usually more tender than lighter ones, reflecting the positive impact of fast growth rates. Points are based on the effects of bone maturity and carcass weight on eating quality, as identified by MSA.

*Bos indicus* content of the live animal has been shown by consumer testing to have a significant negative impact on eating quality, compared to British and European breed types, even when other factors such as weight for maturity are equal. The grilling cuts are the most affected. Animals with zero *Bos indicus* content receive maximum points for this trait.

**Marbling** enhances the eating quality of grilling cuts, and to a lesser extent roasting cuts. Carcasses are assessed for marbling at the rib-eye using the AUS-MEAT chips (0-6), with the results reported in 1/10<sup>ths</sup> of a chip. Maximum points are awarded for marbling in the range of chip 2.7 to 3.9.

**Fat Distribution** on a carcass impacts on meat tenderness, through chilling effects, and on carcass yield. Carcasses are assessed on two aspects of distribution, excluding any plant effects. The first is coverage over the major primal areas of the carcass, including the butt, rump, loin, cube roll and shoulder. The second aspect is a subjective assessment of general evenness of fat cover, focussing on excessive fat deposition and penalising uneven and overfat carcasses. Key areas for assessment of fat deposits are the subcutaneous fat, intermuscular (seam) fat and internal fat in the cod, udder, ribs and brisket.
